- Today, tribal justice systems are diverse in concept and character and are at various stages of development.
- Effective tribal courts support economic growth, empower the legislative and executive branches, promote peace and community health, and advance tribal sovereignty.
- Not only are HTWCs a leader for restorative justice systems in the U.S., but they are an active practice of tribal sovereignty.
