



Na Peuykam Chibel Court "New Beginnings" Juvenile Drug Court Program

- Alternate 6 Month regimented Youth Court Program










Exposure to Traditions

YDSP Youth Council


- Mentoring







Identify if You Have a Tribal member

- Ask During Staffing, family, the participant
- Research
- Learn best practices
- Reach out to the members nation



Research



- Learn about the child's community
- Learn about their community
- Identify if the child is active in their tribal community and culture
- Identify a tribal point of contact
- Identify if there may exist cultural trauma within that child's community that contributes to the issue



Cultural Awareness

- Never Assume
- It is acceptable to admit limited knowledge of NA cultures, and invite people to educate you about specific cultural protocols in their community.
- Not all tribal customs and traditions are the same
- Many NA families are multicultural and adapt to their surrounding culture and may share customs and traditions from both



Spirituality

- Traditional spirituality practices are integrated into NA culture and day-to-day living.
- It is common practice to open and close meeting with a prayer or short ceremony.
- Specific practices such as ceremonies, prayers, and religious protocols will vary among NA communities
- Respectfully ask if you court participant is active in his communities spiritual practices



Self Awareness and Etiquette – DON'Ts

- NEVER use any information gained by working in the community for personal presentations, case studies, research, and so on, without the expressed written consent of the Tribal government or Alaska Native Corporation.
- Do not touch sacred or ceremonial items or personal or cultural items. When in doubt, always ask. It demonstrates respect and a desire to learn.
- If you have distant AI/NA relatives and you have not maintained a connection with that AI/AN community beware using this as an attempt to establish rapport.
- Take part in their offering of a meal.

In the End

- It is your Wellness Program
- Be honest and clear about your role and expectations and be willing to adapt to meet the needs of the community—they are in your program
- Show respect by being open to other ways of thinking and behaving and find balance where possible for the betterment of your program and of the participant.

Why Collaboration is Important

- Allows State and Tribal Courts to work together.
- Reconnect Children to their native community.
- Where children are older and may have been separated from their tribal community we have developed the "Culture Camp".
- The Goal of the Camp is to increase the Knowledge of Tribal children in Foster or Kinship care to learn their Pueblo customs, traditions and history.
- The Component of the Camp is taught by Tribal members and Tribal Elders.
