

- Identify referral gaps that lead to harm for Native clients.
- Understand role boundaries between courts, clinicians, and Tribal programs.
- Apply a culturally grounded referral model to improve outcomes.





► **“WHEN SYSTEMS ALIGN, LIVES ARE SAVED.”**



► THE STORY BEHIND THE SILENCE

- Native clients were referred to Arizona substance misuse programs without proper clinical assessment.
- Some were severely mentally ill (SMI) and needed higher-level care.
- These inappropriate placements led to clients going missing or getting caught in Medicaid fraud schemes.
- This is not about blame—it's about finding solutions.



► CLARIFYING THE CHALLENGE

- The system often asks social workers to make referrals they are not clinically equipped for.
- Behavioral health departments (Tribal/non-Tribal) are often bypassed.
- This gap increases risk and breaks continuity of care.



REAL CONSEQUENCES

- Clients misdiagnosed or placed in wrong level of care.
- Many leave programs Against Medical Advice (AMA).
- Vulnerability to homelessness or exploitation.


Support, Not Clinical Assessment

POSITIVE SOLUTION – “STAY IN YOUR LANE” PROTOCOL

- Respect clinical boundaries.
- Courts refer to Behavioral Health (BH), not to programs directly.
- Establish Memorandum of Understandings (MOUs) with Indian Health Services (IHS)/638 and local BH departments.
- Hold joint staffing or pre-referral case meetings.





By strengthening coordinated referrals with Tribal Behavioral Health, it is possible to significantly reduce AMA discharges and improve client retention.


Culturally responsive, integrated approaches keep clients engaged longer and improve outcomes.





CULTURAL CARE AS A SAFETY NET

- Clinical treatment and traditional care are both needed.
- Wrap programs with ceremony, mentorship, and cultural healing.
- Culture is prevention—but treatment must still be clinically guided.





CALL TO ACTION







LET'S COMMIT TO THESE 3 THINGS:
